

# Geelong East Primary School Student Dress Code

Our student dress code meets human rights and anti-discrimination requirements, includes exemption processes and addresses health and safety considerations.

#### **PURPOSE**

The purpose of the Student Dress Code is to outline Geelong East Primary School's requirements for student dress and appearance and to provide information about uniform purchase and support, dress code implementation and exemption processes.

This dress code has been developed by Geelong East Primary School's School Council in close consultation with our school community to ensure that it respects the rights of individual students whilst reflecting the values and interests of our community.

The Student Dress Code aims to:

- foster a sense of community and belonging and encourages students to develop pride in their appearance
- support Geelong East Primary School's commitment to ensuring that our students feel equal and are dressed safely and appropriately for school activities.
- reduce student competition on the basis of clothing
- enhance the profile and identity of the school and its students within the wider community.

The School Council has developed a dress code that we believe provides a range of choices for students and is cost effective for families.

# **SCOPE**

Students are expected to comply with this Student Dress Code while traveling to and from school, during school hours and when attending school activities unless specific permission given by School Council for a change ie footy colours day.

# UNIFORM AND APPEARANCE

The full list of Geelong East Primary School's compulsory school uniform items are available at Appendix A to this policy.

#### **General appearance**

While at school, travelling to or from school or participating in school activities, Geelong East Primary School students must comply with the following:

- Uniforms must be clearly marked with the owner's name
- Additional layers of clothing may be worn underneath the uniform for added warmth, provided these undergarments are completely hidden.

#### **Jewellery and cosmetics**

Students are not permitted to wear decorative jewellery to school. Stud earrings and sleepers worn in the ears, and watches, are the only acceptable jewellery.

Cosmetics may not be worn at school. Only clear nail polish is permitted.

# Hair and Sun safety

Shoulder length or longer hair is to be tied back to help restrict the spread of nits and lice and for student safety.

#### PROPOSED ADDITION:

Hair should be natural colours so that distraction to learning does not occur and the wellbeing of students is considered.

School uniform hats must be worn outside from mid-August (exact date to be set by the school annually) to 30 April and on any other day prescribed by the school. School uniform hats may also be worn outside of this time period, by parent or student choice. If children are not wearing their hats they must be seated under the shade cloth.

Hats are not to be worn inside.

Students are permitted to wear sunglasses during outdoor activities. Sunglasses should be close-fitting, wrap-around that meet the Australian Standards 1067 and cover as much of the eye area as possible.

#### PURCHASE OF UNIFORMS

Uniform items can be purchased from Belezza or A+ Uniforms.

Geelong East Primary School Parents' Club also has second-hand uniforms for parents at low cost.

# **Support for families experiencing difficulty**

Please contact the Principal to discuss support that we may be able to provide to families experiencing difficulty meeting uniform costs, including information about eligibility for uniform support through State Schools' Relief. Geelong East Primary School also has uniforms available to families to borrow on request.

# **IMPLEMENTATION**

Geelong East Primary School will ensure that this Student Dress Code is communicated to all families and students through our website and transition into our school We will assist students who may be experiencing difficulties complying with this policy where possible.

Students wearing non-compliant uniform items may be asked to change into a compliant item of clothing provided by the school.

If a student is out of school uniform or otherwise breaches the Student Dress Code on a recurring basis, a note will be provided to the student and parents by the classroom teacher. If non-compliance with the dress code becomes a continued occurrence, the Principal will be informed and a phone call home may be required. In this event, the school will continue to work with the student and family to support compliance.

Measures taken by Geelong East Primary School to address concerns about student non-compliance with the Student Dress Code will also be addressed in accordance with our Student Wellbeing and Engagement Policy.

#### **EXEMPTIONS TO STUDENT DRESS CODE**

We recognise that there may be situations where the application of this dress code may affect students unequally.

Students and their parents or carers may apply in writing to the Principal for an exemption to this Student Dress Code if:

- an aspect of this code prevents the student from complying with a requirement of their religious, ethnic or cultural beliefs or background
- the student has a particular disability or health condition that requires a departure from the dress code
- the student or their parents/carers can demonstrate particular economic hardship that prevents them from complying with the dress code.

When the Principal receives a request for an exemption, they will:

- consider the grounds for the exemption request
- explain the process to the student and/or their parents/carers
- encourage the student and/or their parents/carers to support their application with evidence.

The Principal or delegate will then try to negotiate a resolution that is acceptable to all parties. If an exemption is not allowed, then written reasons will be provided to the student and/or their parents or carers.

# APPENDIX A: GEELONG EAST PRIMARY SCHOOL UNIFORM ITEMS

# All year round

The following items may be worn all year round, with either the summer or winter uniform:

# **Jumper or Vest**

Green polar fleece with school logo

Bottle Green polar/vest fleece with school logo

#### Polo shirts

Red or Bottle Green long and short sleeved with school logo.

#### Skorts

Plain navy skorts without decoration or brand name and in winter can be worn with Bottle Green tights/stockings.

# **Socks or tights/stockings**

Grey, black or white socks

Bottle Green tights/stockings

#### **Footwear**

Appropriate footwear is to be worn. Summer sandals with covered toes, black or brown school shoes or pull on school boots or runners are permitted. No thongs or open-toed sandals are permitted.

# School Rain Coat (Optional Item)

Bottle Green coat with red collar and school logo

# Headwear

Bottle green or white head bands, hair ribbons, "scrunchies" or headwear worn as part of cultural/religious beliefs. Elastic Bands used to tie up hair may be worn in any colour.

# Summer Uniform – to be worn in Terms 1 and 4

# Dresses

Summer Green and white checked dress

#### **Shorts**

Plain Bottle Green shorts without decoration or brand name

# Winter Uniform – to be worn in Term 2 and 3

#### **Pants**

Plain, Bottle Green track pants without decoration or brand name

#### **Skivvies**

Plain green skivvy

# Hats – to be worn from mid-August to 30 April

Bottle Green broadbrim without decoration or brand name.

# **Sports uniform**

Green polo top with bottle green shorts/skirt/skort.

There are specific uniform requirements for students participating in specialist sports. These uniforms are provided by the school for the duration of the sports season.
